SIMPLE DEFINITION (in general; may be other criteria)	A Member is one who: has completed the application & acceptance process; is 16 years of age or older; is ordinarily a resident of BC; has paid membership dues; has an interest in Governance (eg.voting on resolutions at AGMs, electing the Board, amending bylaws); has the opportunity to join the Board.	A Staff or Faculty Member is one who has an employment contract with VJLS-JH.	A Student is one who is enrolled in any of the programs in Children's World or VJLS. Two general subcategories are students under the age of 18 and Adult Students who are over 18 years.	A Parent/Guardian is the guardian of the Student under the age of 18.	A Community Individual is one who supports the organization through many different means/avenues. This group includes Alumni/former students, and generally anyone who is interested in the mission, purpose, programs, events, etc.	A Community Partner is an Organization with whom we have partnered or have a relationship with through the Japanese Canadian Community, international relations, our DTES neighbourhood, non-profit charities, the Heritage & Historical Community, Educational organizations, Governments, etc.	A Donor is one who has generously donated funds and is eligible for an official receipt for tax purposes.
